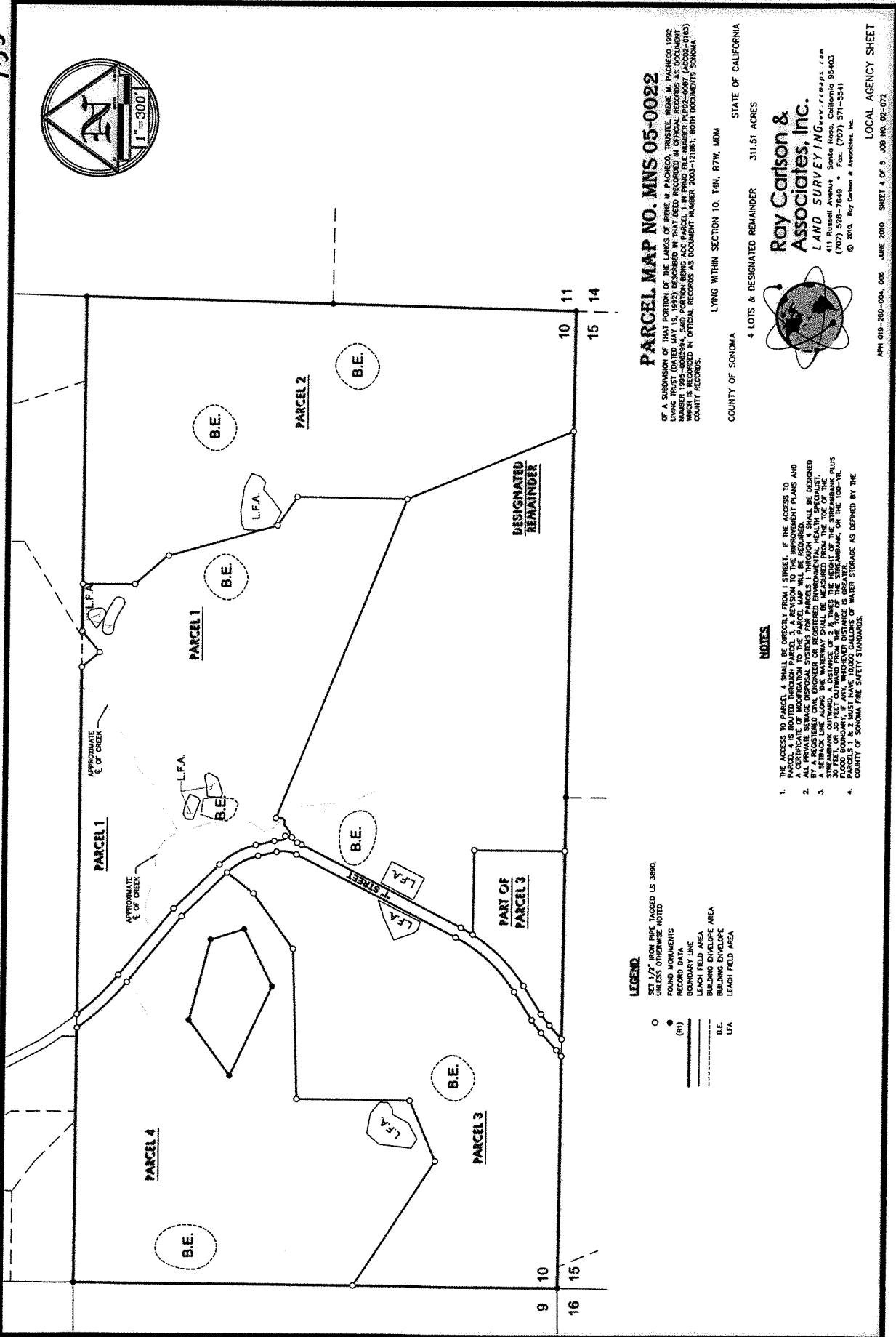
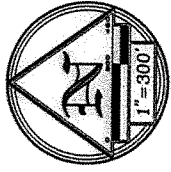

1. THE ACCESS TO PARCEL 1 SHALL BE DIRECTLY FROM A STREET. IF THE ACCESS TO PARCEL 1 IS ROUTED THROUGH PARCEL 2, A CERTIFICATE OF MONIFICATION TO THE PARCEL MAP WILL BE REQUIRED.
2. A CERTIFICATE OF MONIFICATION TO THE PARCEL MAP WILL BE REQUIRED.
3. A SETBACK LINE ALONG THE WATERWAY SHALL BE MEASURED FROM THE TOE OF THE BANK TO THE CENTERLINE OF THE WATERWAY. THE SETBACK SHALL BE 30 FEET, OR 50 FEET OUTWARD FROM THE TOE OF THE BANK PLUS 30 FEET, OR 50 FEET, WHICHEVER DISTANCE IS GREATER.
4. PARCELS SHOWN WITH A B.E. OR L.F.A. SHALL BE SUBJECT TO THE LOCAL AGENCY'S WATER STORAGE AS DEFINED BY THE COUNTY OF SONOMA FIRE SAFETY STANDARDS.
